- Supervise Jibu's Head of Operational Finance to perform day-to-day tasks in each country in conjunction with Jibu's OpCo Financial Controllers and Country Directors
- Lead the company's treasury management to ensure the liquidity needs of the business are met and cash is optimally managed within a multi-jurisdiction environment.
- Debt management: Negotiating and managing the company's borrowings
- Coordinating external financial reporting and tax compliance with support of external accountants / auditors and tax advisors.
- Oversight of group-wide internal controls, financial policies and coordinating controls reviews.
- Lead the company's annual budgeting and periodic forecasting process
- Providing finance Leadership, mentoring and managing the accounting and financial staff.
- Stakeholder management: Executive lead for the Finance Committee, leading investor relations, strategic banks relationship management and presenting financial performance at stakeholder meetings.
